What will China do about corruption?

China will deepen efforts to crack down on corruption in finance, state-owned enterprises, energy, tobacco, medicine, infrastructure projects, and bidding, also with focus on cross-border corruption.

Is Xi a tough stance against corruption?

Addressing the third plenary session of the 20th CPC CCDI on Monday, Xi highlighted the importance of maintaining a tough stance against corruption, stressing that in the continued grave and complex situation, there is no possibility of stopping, slackening or compromising the anti-corruption campaign. What is the CPC Central Committee doing to combat corruption?

The CPC Central Committee has, under the guidance of the rule of law, made unremitting efforts to improve conduct, enforce discipline, combat corruption, consolidate mechanism-building as a cage to contain powers, and constrain abuse of power. The reform of the national supervision system is a milestone in the Party's anti-corruption campaign.

When is China's Anti-Corruption plenary session?

BEIJING -- Typically, after New Year's Day and leading up to Spring Festival, the Communist Party of China's (CPC) top disciplinary agency convenes a plenary session, setting out its anti-corruption priorities for the year ahead.

Does the CPC have a problem with corruption?

"The CPC does not operate in a vacuum, so it has unavoidably found itself with problems of one kind or another. Corruption is such a persistent one," he told the Wall Street Journal. He went on to say that the people hated corruption more than anything else, and action was needed to allay their concerns.

What will China do about bribery?

China will strengthen joint investigation into bribery as well as officials taking bribes, and improve the joint punishment mechanism for key bribe givers. Also, it will continue to promote national anti-corruption legislation, according to the communiqué;
