Can storage tenders be organized with public support?

A legal framework allowing the organization of storage tenders with public support is now in place, and it will be up to the French State and the transmission system operator to provide further information to market players on future call for tenders.

What is the demand response call for tenders for 2025?

The call for tenders going on 2025 and the S1 2026 has four lots: Lot 4, reserved for storage capacities. For 2025, the maximum volume that can be contracted for the demand response call for tenders is 2,900 MW.

Is TotalEnergies the biggest battery storage project in France?

The energy major has 103MW of capacity market contracted energy storage online or coming online in France. Interestingly however, despite presiding over the single biggest project in the country, TotalEnergies sits second in Clean Horizon's chart of France's most prolific (publicly announced) battery storage project owners and developers.

How many heat pumps are sold in France in 2022?

In contrast, the market for residential heat pumps in France is experiencing significant growth. In 2022, approximately 550,000 heat pumps were sold, including 346,700 air/water heat pumps.

How many MW can be contracted for the demand response call for tenders?

For 2025, the maximum volume that can be contracted for the demand response call for tenders is 2,900 MW. The call for tenders is public: you may answer directly as an extraction site or via a demand response operator /balancing service provider /electricity supplier /scheduling agent. The application form is available on the e-commerce portal.
