

Solar panels have been subject to two Government schemes to pay householders for energy: The feed-in tariff (FIT) - Closed to new applicants in March 2019; The Smart Export Guarantee (SEG) - Active since January 2020; We look at these schemes and their differences below as well as asking whether installing solar panels is still worth it.

Buying land. Foreigners cannot buy land as sale of land to foreigners has been prohibited from the 2013 budget. Land can only be leased out for a max of 99 years. Foreigners or companies (with more than 50% foreign ownership) no longer need to pay the 15% land tax from 1st Jan 2016 (LAND (RESTRICTIONS ON ALIENATION) (AMENDMENT) - issued 2nd ...
