Do temporary workers pay tax in Serbia?

In general, employees seconded to temporary work abroad must still pay income tax in Serbia at the same rate as Serbian residents. The basis for taxation is the salary that the assigned employee would have received if that employee had worked in Serbia in the same or a similar work post.

How long do you have to give severance pay in Serbia?

Employers must give an employee eight days notice before the dismissal (five days during probation). An employee terminating the employment contract must provide 15 days' notice. In the event of layoffs, a notice period of 30 days is required. In Serbia, severance pay is only paid in the case of layoffs.

How is harassment at work regulated in Serbia?

Protection from harassment at work is regulated by the Law on Preventing Harassment at Work (Zakon o spre#avanju zlostavljanja na radu, Official Gazette of the Republic of Serbia, No. 36/10), which provides for the definition of harassment and regulates the obligations of both employers and employees in this respect.

How many hours a week do you work in Serbia?

Employers may issue bonuses at their discretion. The working week in Serbia is typically 40 hours, eight hours per day, five days a week. All work above the standard working hours per week is to be paid as overtime and is regulated by the employment contract/collective agreements.
