



# Solar power generation system invoicing tax rate

What is the GST rate for a solar power generating system?

Support the solar industry. The applicable GST rate for supply of equipment for a solar power generating system (composite supply) will be 12% (the value can be equivalent to 70% of the plant cost).

What is 0% VAT on solar panels?

The 0% VAT on solar panels in the UK is a temporary measure, set to last until 31 March 2027. From 1 April 2027 onwards, the VAT rate on solar panel supplies will go back to the reduced rate of 5%, in line with the UK government's financial and renewable energy goals. Does 0% VAT apply to solar batteries?

How much VAT does a solar panel business charge?

This means that the solar panel business will have to calculate a value for this consideration and then charge 5% (or 20%) VAT as necessary, on this amount if they are VAT registered.

Are solar panels tax-free in the UK?

The supply and installation of "energy saving materials", including solar panels, is currently subject to a reduced VAT rate of 5% in the UK. The European Commission is currently challenging this policy, arguing that the tax incentive goes beyond the scope of the law.

Are solar thermal and PV systems subject to VAT?

Solar thermal and PV systems are included on the list of ESMs. Their supply and installation are now subject to 0% VAT in Great Britain. In Northern Ireland, the previous rules remain in force. This means that solar is subject to 20% VAT unless a reduced rate of 5% applies.

Are solar panels VAT free?

Whether you're buying a standalone solar battery or getting a battery installed with a solar panel system, you'll benefit from the 0% VAT rate. This rule changed in February 2024 to include standalone storage batteries at the 0% VAT, regardless of whether you're getting solar panels at the same time. Is there VAT on solar panel income?

4.1.1 Rate of solar power generating system. Under GST regime, various rates have been prescribed for goods and services. Per, Notification No. 1/2017 -- Integrated tax (Rate) dated 28 Jun 2017, solar power generating systems and parts for their manufacture are taxable at 5%. The relevant entry reads as follows:

For example, if a business invests Rs. 1 crore in a solar power plant, it can claim depreciation of Rs. 80 lakh in the first year itself.
