Is there a zero-rate VAT on solar panels?

A zero-rate of VAT on the installation of energy-saving materials (ESMs), including solar panels, in residential accommodation, was introduced on 1 April 2022. At the time, it only applied to England, Scotland, and Wales. Following a new agreement between the UK and the EU, the zero-rating was also implemented in Northern Ireland on 1 May 2023.

Do you pay VAT on solar panels?

If you buy solar panels from one provider and have them installed by someone else, you'll be hit with a standard 20% VAT rate when buying them. Plus, any maintenance or repairs after installation will be at the standard VAT rate.

Are solar panels tax deductible in the UK?

According to the UK government's list of Energy Saving Measures (ESMs), most solar photovoltaic (PV) panels installed on residential properties in Scotland, England and Wales (plus Northern Ireland, as of 1 May 2023) are exempt from VAT, meaning there's no VAT included in the purchase and installation costs.

Are solar and energy storage installations subject to VAT?

All solar and energy storage installations, including maintenance to existing sites, should be subject to 0% VAT. This should include residential energy storage when installed as a standalone measure.

The sale of a photovoltaic system is not exempt from VAT, but the supplier or installer invoices the customer for the net price "plus 0 per cent VAT". A VAT exemption would have the consequence that the installation ...

A VAT invoice can only be issued by a VAT registered business and must legally contain certain information, which is detailed in VAT Notice 700/21, section 5. The legislation specifies two types of VAT invoices: less detailed invoices for supplies under £250, and full VAT invoices for supplies over £250. And they are required for standard and ...
