Can a woman put solar panels on a Grade II listed home?

A woman who put solar panels on her Grade II listed home without permission is to remove them after being warned she could go to prison. Environmental activist Mary Smail, who already has a criminal record for taking part in climate action, said she did not want to risk being jailed.

Did 16 solar panels 'harm' to 'heritage assets'?

The council said the 16 solar panels caused 'harm' to 'heritage assets'. Ms Smail, 64, from Church Street in Ashbourne, applied to the council for planning permission to install the solar panels but said she was advised there was no chance of it being granted due to the historic nature of the area.

Do solar panels need planning permission?

However, putting solar panels on listed buildings and those within conservation areas usually does require planning permission. In addition to planning permission, Listed Building Consent is required for changes to a listed building in any manner which would affect its character as a building of special architectural or historic interest.

Did a retired Suffolk farmer buy a solar battery?

Among his many victims was a retired Suffolk farmer I'll just call by his first name, Graham. Although registered with the Telephone Preference Service, Graham was repeatedly phoned about products for his solar heating system. A call on March 4, 2016, resulted in him buying a storage battery for £5,900.
