Any excess electricity produced can be stored in a battery, or other storage solution like your hot water immersion tank or Electric Vehicle. If 6 PV panels are erected on an independent supporting structure and the weight of each PV panel is around 26kg. The weight of the system supported by the structure will be 156kg (i.e. 26kg  $\times$  6 PV panels).
